

# 3-4 yr old Government Funding: How Much Will

At St Georges Nursery-Dragons, we recognise that understanding your childcare costs can sometimes be confusing. To provide some clarity on fees including government funding, we have outlined examples below of the childcare sustainability costs:

## FUNDED SESSIONS ONLY

**Question:** I am eligible for 15 hours universal government funding. How much will I pay for a Morning or an Afternoon **Funded Only** Session?

**Answer:** All 3-4 year olds are entitled to 15 hours universal government funding. This scheme is payable to all early years providers the term after your child's 3<sup>rd</sup> Birthday. Families at St George's Nursery usually take their entitlement over five morning or afternoon sessions, 3 hours per day, from Monday to Friday. **There is also funding available for eligible 2 year olds.**

(This does not include meals or snacks)

## MORNING / AFTERNOON SESSIONS

**Question:** I am eligible for 15 hours universal government funding. How much will I pay for a **Morning** or an **Afternoon Place**?

**Answer:** All 3-4 year olds are entitled to 15 hours universal government funding, the term after their 3<sup>rd</sup> birthday. If your child attends a **Morning** or **Afternoon** session with the 15 hours, once government funding is applied, you will pay approximately:

£11.78 Daily

Rates based on stretched funding on an **All Year Round** basis

(This includes Meals, Snacks and extra-curricular activities)

## CORE DAY SESSIONS

**Question:** I am eligible for 30 hours universal government funding. How much will I pay for a **Core Day Place**?

**Answer:** Some 3-4 year olds are eligible for an additional 15 hours giving you a total of up to 30 hours Government Funding. If your child attends a **Core Day** with 30 hours, once government funding is applied, you will pay approximately:

£18.84 Daily

Rates based on a **Term Time** basis

£25.27 Daily

Rates based on stretched funding on an **All Year Round** sessions

(This includes any extra hours, Meals, Snacks and extra-curricular activities)

## FULL DAY SESSIONS

**Question:** I am eligible for 30 hours universal government funding. How much will I pay for a **Full Day Place**?

**Answer:** Some 3-4 year olds are eligible for an additional 15 hours giving you a total of up to 30 hours Government Funding. If your child attends a **Full Day** with 30 hours, once government funding is applied, you will pay approximately:

£37.14 Daily

Rates based on a **Term Time** basis

£43.57 Daily

Rates based on stretched funding on an **All Year Round** sessions

(This includes any extra hours, Meals, Snacks and extra-curricular activities)

Fees are payable for Extra-Curricular Services or hours outside the 15hr or 30hr entitlements.
